Welcome to **Endless Stories** ("Service") provided by **Coxe Industries LLC** ("we," "our," or "us"). These Terms of Service ("Terms") govern your use of our website located at <https://endlessstories.ai> ("Website") and the services provided therein. By accessing or using the Service, you agree to these Terms.

1. Definitions

- **"Service"** refers to the Endless Stories platform, where users can purchase credits and use them to generate stories.
- **"User"** means any individual or entity that registers for, accesses, or uses the Service.
- **"Credits"** are units purchased by the User that can be redeemed to generate stories, images, text, or audio through the Service.

2. Eligibility

- Credits are non-refundable and cannot be transferred to other accounts.

5. Payments

- All payments for credits are processed securely through Stripe, our third-party payment processor. By providing your payment information, you authorize Coxe Industries LLC to charge the designated payment method for the number of credits you purchase.
- You are responsible for providing valid payment information and ensuring that sufficient funds are available to complete the transaction.

6. Refunds

- Credits are non-refundable, except in cases of technical errors or issues directly related to the Service. If you believe a refund is warranted, you may contact us at info@coxeindustries.com, and we will evaluate refund requests on a case-by-case basis.
- Refunds, if granted, will be processed via the same payment method used for the original transaction.

7. Use of the Service

- You agree to use the Service for lawful purposes only. You must not use the Service in any way that violates applicable laws or infringes on the rights of others.
- You must not attempt to disrupt the Service or interfere with the operation of the Website, such as by hacking, uploading malicious code, or initiating denial-of-service attacks.
